NRCS Conservation Programs Annual Report

Conservation Stewardship Program (CSP) -

CSP is for working lands. It is the largest conservation program in the United States with 70 million acres of productive agricultural and forest land enrolled in CSP. Thousands of people have made the choice to voluntarily enroll in the program because it helps them enhance natural resources and improve their business operation.

<u>Total overall CARROLL COUNTY CSP contracts – 16</u> <u>Total acres – 18,146.8</u> <u>Total Obligation Amount – \$969,849</u>

Environmental Quality Incentives Program (EQIP) -

Through EQIP, farmers and ranchers receive financial and technical assistance to implement structural and management conservation practices that optimize environmental benefits on working agricultural land.

2019 new contracts - 12 covering 1,785.3 acres with total obligation of \$218,649

USDA Announces Signup for Conservation Reserve Program

USDA opened signup for the Conservation Reserve Program (CRP) on December 9, 2019.

Farmers and ranchers who enroll in CRP receive a yearly rental payment for voluntarily establishing long-term, resource-conserving plant species, such as approved grasses or trees (known as "covers") to control soil erosion, improve water quality and develop wildlife habitat on marginally productive agricultural lands.

The 2018 Farm Bill prioritizes water quality practices, CRP continuous signup will focus primarily on water quality with the Clean Lakes, Estuaries, and Rivers (CLEAR) Initiative.

USDA will also be working with Conservation Reserve Enhancement Program (CREP) partners to relaunch CREP continuous options in each state under new statutory provisions. CREP will continue to target highpriority local, state or regional conservation concerns

> CRP Enrollment Options General Signup

CRP general signup will be held annually. The competitive general signup will now include increased opportunities for enrollment of wildlife habitat through the State Acres For Wildlife Enhancement (SAFE) initiative <u>This year's General signup runs from **December 9**, **2019 – February 28**, **2020**</u>

Continuous Signup

CRP continuous signup will focus primarily on water quality with the Clean Lakes, Estuaries, and Rivers (CLEAR) Initiative. Prioritizing water quality practices such as contour grass strips, filter strips, riparian buffers, wetlands and a new prairie strip.

These practices can be applied for at any time throughout the year.

To apply for Deer Creek-Sugar Creek Watershed Cost-Share Program Funds

Landowners in critical areas of the Deer Creek-Sugar Creek Watershed are eligible to apply for cost-share funding to implement best management practices. Eligible practices include those that will reduce loading of Nitrogen and Phosphorus *E. coli*, and Total Suspended Solids in water runoff. Additional practices to keep livestock out of creeks are also eligible for funding. Targeting Little Deer Creek and Sugar Creek areas of the watershed.
